Broadway House Hosts NJ DOH Listening Session

NJ is ending the HIV Epidemic and in order to get direct input from those affected by HIV, the NJ Department of Health's *Taskforce to End the HIV Epidemic* held listening sessions throughout the state with the Newark session being hosted at Broadway House. By 2025, NJ seeks to:

- Reduce the rate of new HIV infections by 75%
- Ensure that 100% of persons living with HIV/AIDS know their status
- Ensure that 90% of persons diagnoses with HIV/AIDS are virally suppressed



Approximately 100 community members attended the forum that was moderated by NJ DOH Assistant Health Commissioner Christopher Menschner. "The state's campaign builds on a groundwork of advocates to bring everyone together to curb the spread of HIV and stop anyone dying from AIDS," he said. Gary Paul Wright, a Broadway House board member, is a Task Force member.
